

RESOLUTION 2024- 004

A RESOLUTION AUTHORIZING THE FORD COUNTY ELECTION OFFICIAL TO SUBMIT TO THE ELECTORS OF THE CITY OF BUCKLIN, KANSAS, THE QUESTION OF IMPOSING A SPECIAL ONE PERCENT (1%) CITYWIDE RETAILERS' SALES TAX QUESTION ON THE NOVEMBER 5, 2024 GENERAL ELECTION BALLOT.

WHEREAS, K.S.A. 120187 *et seq.*, as amended (the "Sales Tax Act") authorizes the Governing Body to submit to the electors of the City the question of imposing a citywide retailers' sales tax, which may be in an amount not to exceed two percent (2%) for general purposes and in an additional amount not to exceed one percent (1%) for special purposes, provided sales taxes for special purposes shall expire ten (10) years from the initial date of collection thereof; and

WHEREAS, the Governing Body deems it advisable that funds be derived to finance all general and lawful projects and purposes, to include but not be limited to, the repair, rebuilding, and rehabilitation of streets and infrastructure, the construction and improvement of public school facilities, and any financing therefor; and

WHEREAS, to finance the costs of such improvements, the Governing Body deems it advisable to submit to the voters the question of imposing a one percent (1%) citywide retailers' sales tax, the proceeds of which would be divided as follows: one-half of one percent (0.5%) to the City of Bucklin for general and lawful purposes; and one-half of one percent (0.5%) to Unified School District (U.S.D.) 459, for general and lawful purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF BUCKLIN, KANSAS:

SECTION ONE: The City Council hereby authorizes the County Clerk of Ford County, Kansas, which is also the County's Election Official, to place the following sales tax ballot question on the general election ballot to be held November 5, 2024:

Shall the following be adopted?

"Shall the City of Bucklin levy a general purpose retailers' sales tax in the amount of one percent (1%) to take effect January 1, 2025, on retail sales consummated within the City of Bucklin; the proceeds of which shall be divided as follows: one-half of one percent (0.5%) to the City of Bucklin, and one-half of one percent (0.5%) to Unified School District (U.S.D.) 459, to be used for all general and lawful purposes?"

SO APPROVED by the Governing Body of the City of Bucklin, Kansas, this 19th day of August, 2024, a majority voting in favor thereof.
